The defective Product(s) must be returned with all transportation charges prepaid by the Customer to Dealer's address or System Level Solutions (India) Private Limited, Plot -32, Zone - D/4, Phase-1, GIDC Estate, V. U. Nagar - 388121 Gujarat, India. SLS will in turn ship the repaired or replacement Product to the Customer, at no additional cost.

In order to claim warranty, Customer shall, establish to SLS's satisfaction –

- (a) that the Customer owns the Product;
- (b) that the Product was installed according to SLS's instructions.

## DISCLAIMERS AND EXCLUSIONS

1. The Limited Warranty described herein-above shall be in lieu of any other warranty, express or implied. Except as set out hereinabove, no other warranties, statutory or otherwise, including warranties of merchantability and fitness for a particular purpose shall apply on the warranted Product(s).
2. The Customer acknowledges to pay the service charges related to on-site visit for repair and replacement of the defective Product(s) or troubleshooting of the Customer's electrical system.
3. The sole and exclusive remedy against SLS shall be the repair or replacement of defective Product(s) as provided hereinabove. No other remedy (including, but not limited to, incidental or consequential damages for lost profits, lost sales, injury to person or property, or any other incidental or consequential loss) shall be available. This exclusive remedy shall not be deemed to have failed of its essential purpose as long as SLS is willing and able to repair or replace defective Product(s) in the prescribed manner.
4. The Customer acknowledges that no oral statements purporting to be warranties, representations, or guarantees of any kind about any product of SLS have been made to Customer by SLS, its affiliates, partners, representatives or dealers, which, in any way, expand, alter or modify the terms of the Limited Warranty set out herein. Any such statements do not constitute warranties, shall not be relied on by the Customer, and are not part of the contract of sale. This writing constitutes a complete and exclusive statement of the terms of any warranty, express or implied, of SLS.
5. There is no warranty for such Product(s) whose defect(s) arise due to misuse, mishandling, neglect, fire, flood, lightning, corrosive atmosphere, defects of other component of solar/photovoltaic system, unauthorized modification of the Product, or, installation or servicing of the Product in a manner not consistent with the instructions issued by SLS.
